**ARTICLES OF ORGANIZATION
OF
ROCK STARS AND MUSCLE CARS, LLC**

The undersigned, desiring to form a limited liability company under and by virtue of the laws of the State of Florida and specifically pursuant to the provisions of Chapter 608, *Florida Statutes (2005)*, does hereby execute these *Articles of Organization*.

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

This Company is to be managed by one or more of its Members and is, therefore, a member-managed company.


ARTICLE V
