## ARTICLES OF ORGANIZATION OF PROVIDENCE STORAGE, LLC, a Florida Limited Liability Company

#### **ARTICLE 1 - NAME**

The name of this Limited Liability Company is: PROVIDENCE STORAGE, LLC

#### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company is: 1100 Osceola Avenue North, Clearwater, FL 33755.

#### **ARTICLE III - DURATION**
