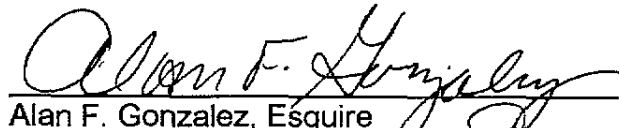

The primary business purpose of this Company is investment, along with any other business purposes permitted by law that the managers of this Company deem prudent and for the benefit of the Company.

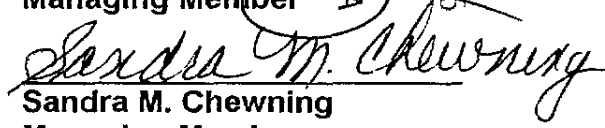
