ARTICLE I - NAME:

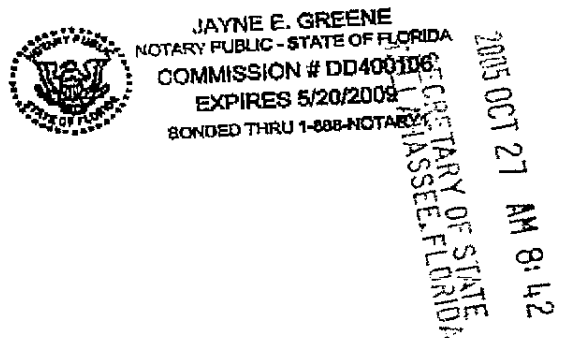


