FOR

The undersigned (the "Organizer") acting as the organizer of Suncraft Properties, LLC, under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is:

**ARTICLE II
INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS**




