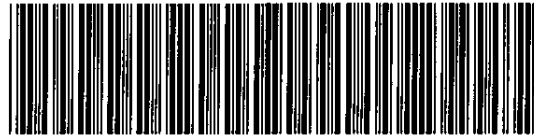

2. The Articles of Organization were filed on October 31, 2005, and assigned document number L05000105976.

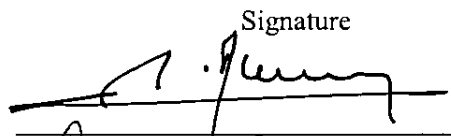
