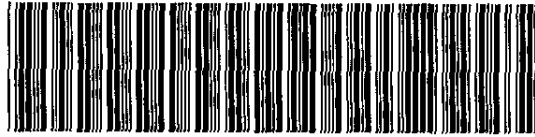

Pursuant to Section 608.407 of the Florida Limited Liability Company Act, the undersigned, as a member of JACKSONVILLE CRANE & MACHINERY, LLC , does hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming a Limited Liability Company under the Laws of the State of Florida.

**ARTICLE I. NAME**


#### **ARTICLE IV. MANAGEMENT**
