

# ARTICLES OF ORGANIZATION

Start of Sta The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be ZABOL MEDICAL, LLC, ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 8726 Hickorywood Lane, Tampa, Florida 33615 and the mailing address shall be the same.

#### <u>ARTICLE 3 - EFFECTIVE DATE</u>

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### ARTICLE 4 - DURATION
