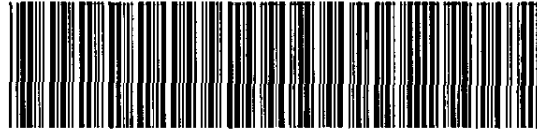

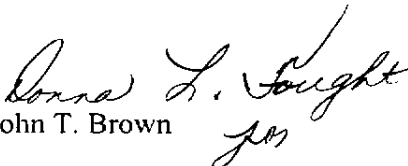

OF**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be BELLY UP OF FWB, L.L.C. ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be: mailing address: P.O. Box 343, Shalimar, Florida 325479; physical address: 100 Sunset Lane, Shalimar, Florida 32579, respectively.

ARTICLE III -- DURATION

ARTICLE VI -- TERMINATION OF EXISTENCE

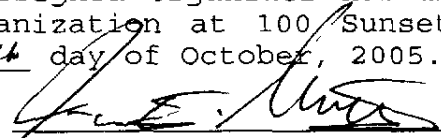
