**ARTICLES OF ORGANIZATION  
OF

a Florida Limited Liability Company**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, *Florida Statutes §608*, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **BIG SUN AUTO SALVAGE, LLC** ("Company").

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

The street address of the principal office of the company shall be **4395 S.E. 95<sup>th</sup> Street, Belleview, Florida 34420** and the mailing address of the company shall be **4395 S.E. 95<sup>th</sup> Street, Belleview, Florida 34420**.

**ARTICLE III - DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE V - ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the Company only on the unanimous consent of all members.

**ARTICLE VI - ADMISSION OF NEW MEMBERS**

No additional members shall be admitted to the Company except with the unanimous written

consent of all the members of the Company and on such terms and conditions as shall be determined by all members. A member may transfer his or her interest in the company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous written consent.

**ARTICLE VII - TERMINATION OF EXISTENCE -  
MEMBER'S RIGHT TO CONTINUE BUSINESS**

The Company shall be dissolved on the death, retirement, resignation, expulsion, bankruptcy, dissolution of a member or on the occurrence of any other event that terminates the continued membership of a member in the Company unless the business of the Company is continued by the consent of all remaining members, provided there is at least one remaining member.

**ARTICLE VIII - INITIAL MANAGING MEMBER**

The Company shall be managed by the members in accordance with the regulations adopted by all members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 
**ARTICLE X - REGULATIONS**



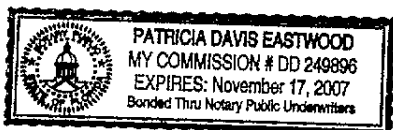
