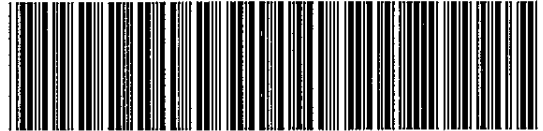

ARTICLES OF ORGANIZATION OF
