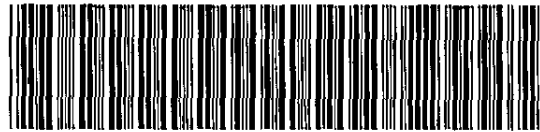

ARTICLES OF ORGANIZATION

OF




