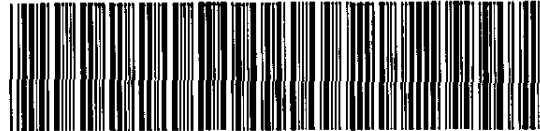

The Company is to be a manager managed Company.


