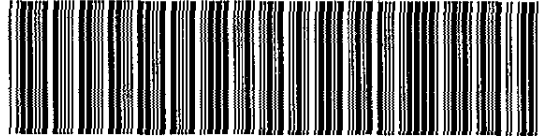

**ARTICLES OF ORGANIZATION  
OF  
NATURALI, PRO, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **NATURALI, PRO, LLC.**

**ARTICLE II -- ADDRESS**

The mailing address of the company is P.O. Box 19902, Sarasota, Florida 34276 and the street address of the principal office of the company is 5820 Wilma Place, Sarasota, Florida 34238-1709.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

#### ARTICLE VII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The business of the company shall be continued on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member unless a majority of the remaining members vote to dissolve the company.

#### ARTICLE VIII -- MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.

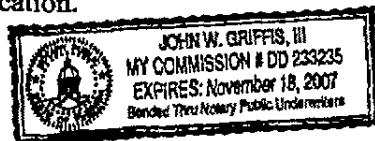


