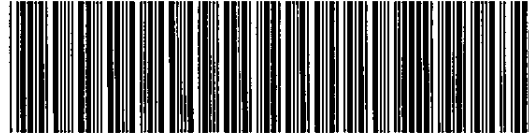

2. The surviving entity will be ARCTIC SPRING, LLC; however, the name of the company will be changed to LABEL THE OCCASION, LLC.

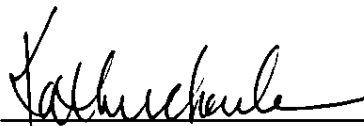
