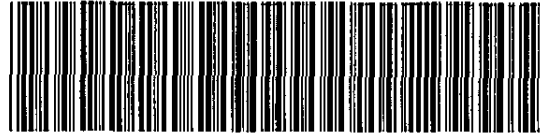


**ARTICLE VI**


