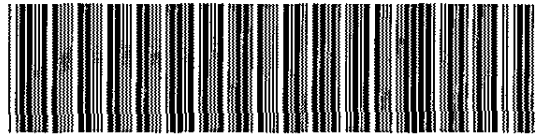

1. Articles of Organization were filed on November 3, 2005, and assigned document number L05000107955.

2. The Articles of Organization are amended and restated in its entirety to read as follows:

"ARTICLE I

NAME

The name of this limited liability company is "**DOOLEYMACK CONSTRUCTORS OF SOUTH FLORIDA, LLC**," referred to in these Articles of Organization as the "Company."

ARTICLE II

PRINCIPAL OFFICE, MAILING ADDRESS AND

REGISTERED AGENT
