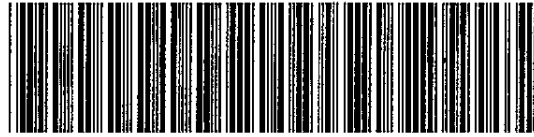

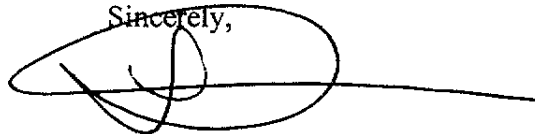

This Professional Liability Company is organized under the provisions of Florida Statutes, Chapters 608 and 621, providing for the formation, rights, privileges, and immunities of Professional Limited Liability Companies for profit. We further declare that the following articles shall serve as the charter and authority for the conduct of business of the Professional Limited Liability Company for the purpose of providing the professional service as are hereafter specified.

**ARTICLE I**

**NAME OF PROFESSIONAL LIABILITY COMPANY**

The name of the Professional Liability Company shall be William Comeau, PLC.

**ARTICLE II**

**PRINCIPAL PLACE OF BUSINESS**

The mailing address and the street address of the principal office of the Professional Limited Liability Company shall be located at 84 Drifting Sands Dr., in the city of Venice, county of Sarasota, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as may be designated.

**ARTICLE III**

**DURATION AND AREAS OF PRACTICE AND SERVICES**

The period of duration for this Professional Limited Liability Company shall be perpetual. The areas of practice and professional services of this Professional Limited Liability Company shall be real estate brokerage, and/or sales, property management and real estate consulting.

#### ARTICLE IV

#### ADDITIONAL PURPOSES AND POWERS

4. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these articles, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the state of Florida.

Nothing contained in these articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the limited liability company to carry on any business, exercise any power, or do any act which a limited liability company may not, under Florida laws, lawfully carry on, exercise, or do.

#### ARTICLE V

#### MANAGEMENT

This Professional Limited Liability Company is a manager-managed Limited Liability Company. The Professional Limited Liability Company shall be managed by the manager(s) who is (are) designated, appointed, or elected to act in that capacity in accordance with the Operating Agreement of the Professional Limited Liability Company.

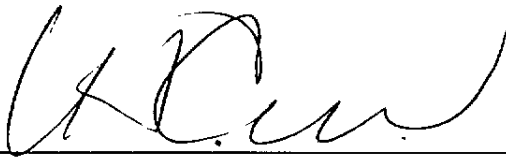

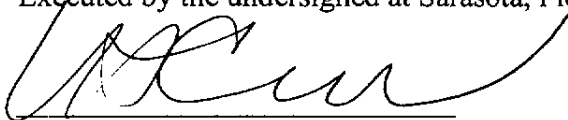
