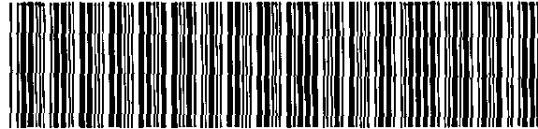

**ARTICLE I.  
NAME**

The name of the Limited Liability Company is "STALLION PROPERTIES, LLC" (the "Company").

**ARTICLE II.  
ADDRESS**

The mailing address and street address of the principal office of the Company is 5073 SE 39<sup>th</sup> Loop, Ocala, FL 34480.

**ARTICLE III.  
DURATION**

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*, Sections 608.401 through 608.514 of the *Florida Statutes Annotated* (the "Act") or the Company's Operating Agreement among the members (the "Operating Agreement").

**ARTICLE IV.  
MANAGEMENT**

The Limited Liability Company is to be managed by a Manager or Managers, as set forth in the Company's Operating Agreement.

**ARTICLE V.  
PURPOSE**

The purpose for which the Company is being organized is to acquire (or lease) and develop, whether in its own capacity or as a joint venture partner, commercial real property, including acquisition and development for office, retail or other commercial uses, and thereafter to manage the same, and ultimately to resell the same, and to transact any other lawful business approved by the Members of the Company and for which a Limited Liability Company may be formed under the laws of the State of Florida.

**ARTICLE VI.

The Company reserves the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by the Act.

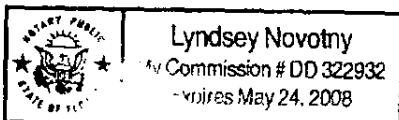

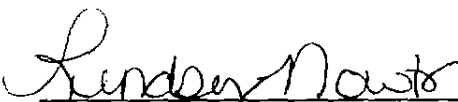

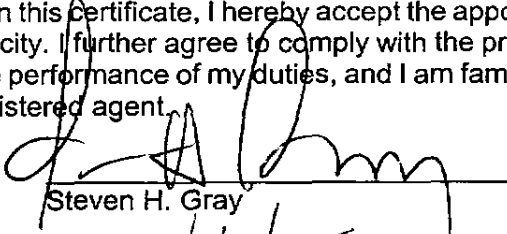
