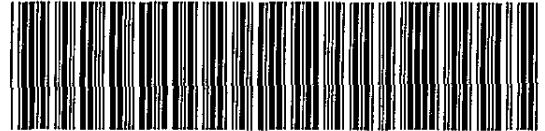




#### ARTICLE VI – ADMISSION OF ADDITIONAL MEMBERS


