



ARTICLES OF ORGANIZATION OF HUBBARD STREET, LLC

A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I

The name of this limited liability company is HUBBARD STREET, LLC

ARTICLE II

The Company's duration shall be perpetual unless sooner dissolved.

ARTICLE III PRINCIPAL OFFICE
