Articles of Organization

of

A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Christy's Carpet Cleaning & Restoration, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.
