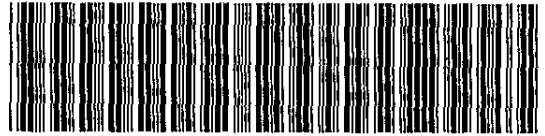


**ARTICLE I** of the Articles of Organization shall be amended to read as follows:
