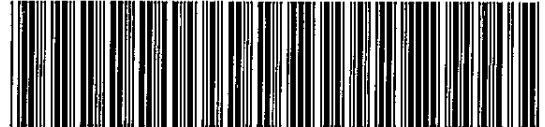

**ARTICLE I.


