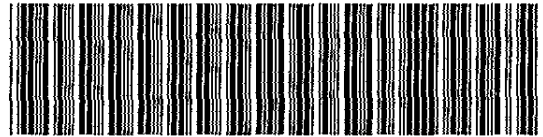

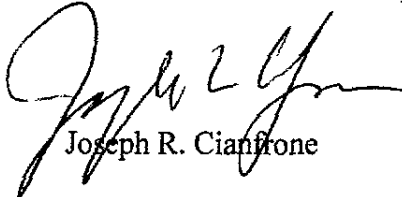

**CERTIFICATE OF
AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR

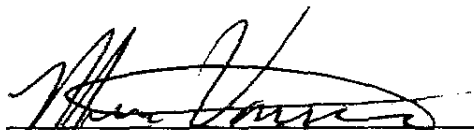

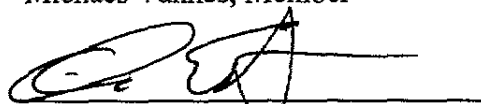

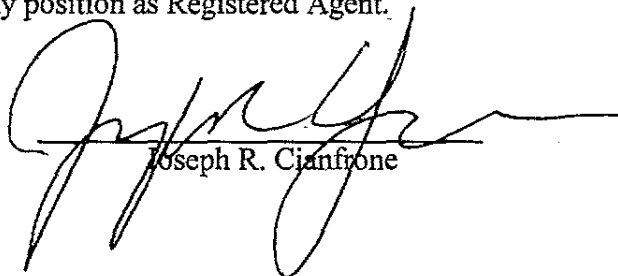
