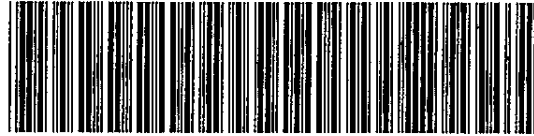

**ARTICLES OF ORGANIZATION OF
SLICER ELECTRIC, LLC**

Article I

The name of the limited liability company ("Company") is SLICER ELECTRIC, LLC.

Article II

The mailing address of the Company is 2130 Spruce Creek Circle West, Port Orange, Florida 32128 and street address of the Company's principal office is 2130 Spruce Creek Circle West, Port Orange, Florida 32128. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV


Article VII
