REGISTERED AGENT

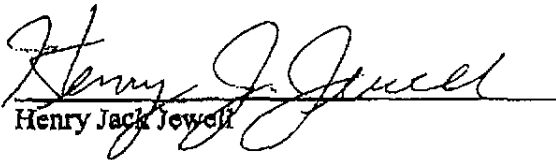

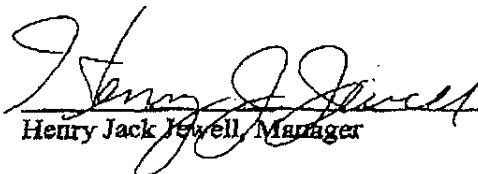
ACCEPTANCE OF REGISTERED AGENT

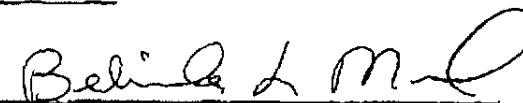
