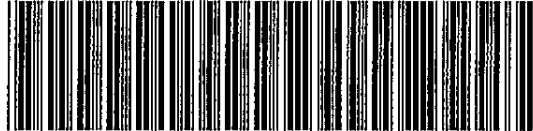

The name of the Limited Liability Company is FULLER STREET VENTURES, LLC.

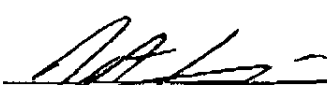
ARTICLE II

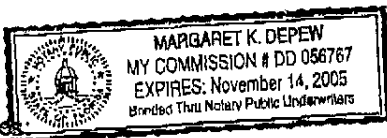

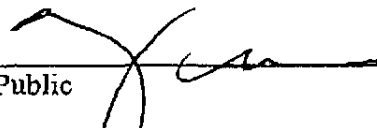
