ARTICLES OF ORGANIZATION OF FLORIDA ESTATE & WEALTH PRESERVATION SOLUTIONS, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.
