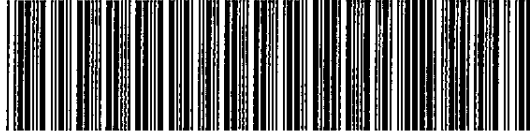

CONTINUATION OF BUSINESS**


