ARTICLES OF ORGANIZATION
LAKE TYLER CONDOS, LLC
A LIMITED LIABILITY COMPANY

1. **Name.** The name of the limited liability company is Lake Tyler Condos, LLC.
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
3. **Address of Principle Office.** The address (mailing and street address) of the principal office of the limited liability company is, 1841 Oakbrook Drive, Longwood, FL 32779.
4. **Term.** Term of this LLC shall be perpetual.
5. **Members at Time of Formation.** There will be at least one member at the time the limited liability company is formed.
