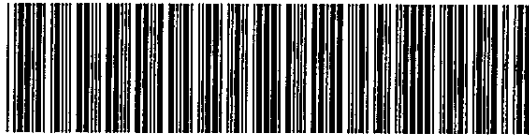

1. **Name.** The name of the limited liability company is Delaney Commons, LLC.
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

7. **Management.** Management of the Limited Liability Company at the time of formation shall be by manager(s) whose name(s) and address(es) are as follows:

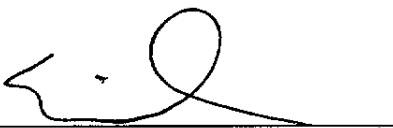
