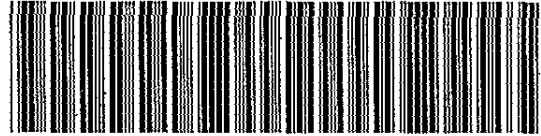

First: The Articles of Organization were filed on November 10, 2005 and assigned Document Number L05000109379.


