

# ARTICLES OF ORGANIZATION OF B.W. BOOTH HOLDINGS, LLC

A STORY OF THE STO

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608)

## Article 1 - Name
