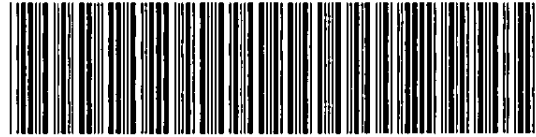

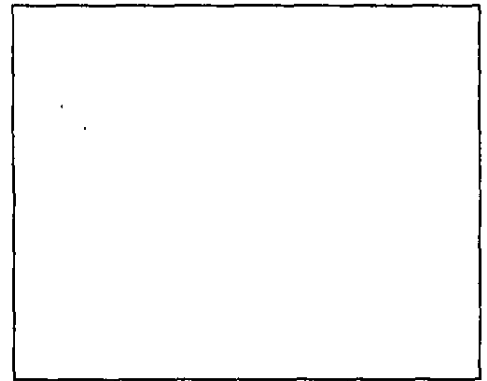

The name of this Limited Liability Company shall be INCOVE INTERNATIONAL, LLC (the "Company")."

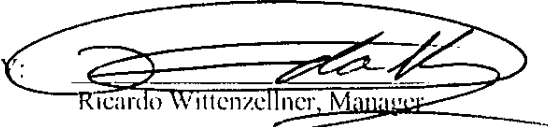
- b. In all other respects, the Articles of Organization shall remain unchanged.
