**ARTICLE I
Name**

ARTICLE V
Registered Office and Registered Agent

ARTICLE VIII
Operating Agreement

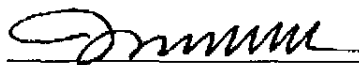

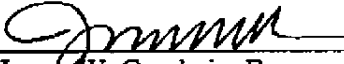
