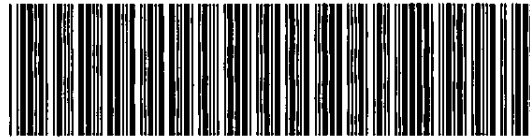

On January 27, 2015, we forwarded to your department for filing the Withdrawal of Member from IOTC Air, LLC and IOTC Aviation, LLC, whereby Daniel Sargeant is withdrawing as a member of both entities.
