

ARTICLES OF DISSOLUTION

The undersigned, being the sole member, desiring to dissolve a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Dissolution:

ARTICLE I. NAME / FILING DATE
