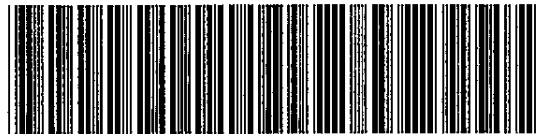

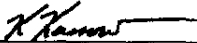
**ARTICLE II. DISSOLUTION APPROVAL AND EFFECTIVE DATES**
