ARTICLES OF ORGANIZATION  
OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

ARTICLE I - NAME

The name of the Company is BAY STREET VILLAGE PROPERTIES, LLC.

ARTICLE II - DURATION

The duration of the Company is perpetual.

ARTICLE III - ADDRESS AND PLACE OF BUSINESS

The street address of the principal place of the principal office of the Company in Florida is 51 S. Tamiami Trail, Osprey, FL 34229, and the mailing address is 8499 S. Tamiami Trail, #250, Sarasota, FL 34238.

ARTICLE IV - PURPOSE

The Company shall indemnify each managing Member, manager and officer to the fullest extent permitted by the Florida Limited Liability Company Act.


ARTICLE IX - COMMENCEMENT OF EXISTENCE
