Second Amendment of Articles of Organization of Global Consulting, LLC

Article IX

Authority of Managing Members. Managing Members shall make decisions regarding the usual affairs of the Company. A majority vote of the membership shall name as many managers as the membership deem necessary and the membership shall elect one Chief Operating Manager who is responsible for carrying out the decisions of the managers.

- f) Execute and deliver all contracts, conveyances, assignments, leases, subleases, franchise and licensing agreements, promissory notes, loans, security agreements, or any other kind relating to Company business.
- g) Establish pensions, trusts, life insurance, incentive plans or any variation thereof, for the benefit of any or all current or former employees, members, and agents of the Company.
- h) Make charitable donations in the Company's name.

For the period 2006-2010, the Chief Operating Manager designated is the Managing Member PEDRO ALFONSI who stated: Having been named as Chief Operating Manager and to accept service of process for the above stated company, I hereby accept the appointment as Chief Operating Manager and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and accept the obligations of my position as Chief Operating Manager.
