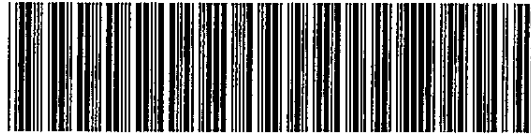

The mailing address and the street address of the principal office of the Limited Liability Company is 7641 W. Highway 40, Ocala, Florida, 34481.

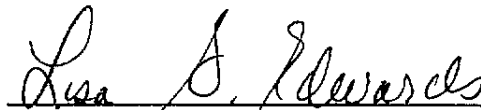
ARTICLE III – REGISTERED OFFICE AND REGISTERED AGENT
