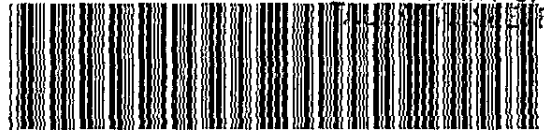

The mailing address and street address of the principal office of the company shall be 11606 Twin Creeks Drive, Fort Pierce, Florida 34945.


ARTICLE III-REGISTERED OFFICE AND AGENT


