FOURTH: Adequate provision has been made for the debts, obligations and liabilities pursuant to section 608.4421, Florida Statutes.


FIFTH: All remaining property and assets have been distributed to the Members in accordance with their respective rights and interests.

SIXTH: There are no suits pending against the Company in any court.


