ARTICLES OF ORGANIZATION

G.E.H., LLC

ARTICLE I - Name: The name of the Limited Liability Company shall be G.E.H., LLC.

ARTICLE II - Address: The mailing address and street address of the principal office of the Limited Liability Company is:

730 NW 7th Avenue

Boca Raton FL 33486

ARTICLE III - Registered Agent: The name and street address of the Limited Liability Company's initial Registered Agent for service of process in this State is as follows: Ilan Kedem, 730 NW 7th Avenue, Boca Raton FL 33486.

ARTICLE IV - Management: The Limited Liability Company will be a manager-managed company and the names and addresses of the two initial managers are:

- Ezra Ivri, 441 Del Prado Boulevard North, Suite 2, Cape Coral FL 33909
- Ilan Kedem, 730 NW 7th Avenue, Boca Raton FL 33486

Upon the resignation of either of the foregoing Managers, the other Manager will be the sole Manager for the Company. The Manager may be changed as provided by any applicable Operating Agreement. Any Manager on his own shall have full authority to open bank accounts for the Company and deposit, disburse, write checks, and otherwise act with regard to the Company's bank accounts.

ARTICLE V - Ownership and Members:

Ownership of the Company is initially established as follows:

Ezra Ivri 90%

Ilan Kedem 10%


The rights, obligations, and other

matters regarding the members may be set forth in an Operating Agreement to be signed by the Managers and the Members.

ARTICLE VI - Transfer of Interests: A Member may not assign or transfer an interest in the Company except as may be allowed by any applicable Operating Agreement.

ARTICLE VII - Members Rights to Continue Business: The remaining members of the limited liability company will have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, subject to such provisions governing such event as may be set forth in any applicable Operating Agreement.

ARTICLE VIII- Applicable Regulations: If the Company does not have an Operating Agreement, as may be allowed under Florida Statutes, then the provisions of Chapter 608, Florida Statutes, or successor statutory provisions, will serve to govern the operations of the Company.
