**ARTICLES OF ORGANIZATION  
OF  
PUNTA GORDA GP, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I  
NAME AND ADDRESS**

The name of the limited liability company shall be PUNTA GORDA GP, LLC ("Company"). The principal place of business of the Company in Florida shall be 4300 Marsh Landing Boulevard, Suite 202, Jacksonville Beach, FL 32250. The mailing address of the Company shall be 4300 Marsh Landing Boulevard, Suite 202, Jacksonville Beach, FL 32250.

**ARTICLE II  
DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE III  
PURPOSES AND POWERS**

The general purpose for which the Company is organized is to be the developer entity for the Phase II land at Punta Gorda, Florida, which is a continuation of Boca Lago at Vivante and will enter into a joint venture and contribute expertise for the development and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

**ARTICLE IV  
MEMBERSHIP RESTRICTIONS**

Members shall have the right to admit new members only by consent of the majority in interest of the membership. Contributions of new members shall be determined as of the time of admission to the Company.
