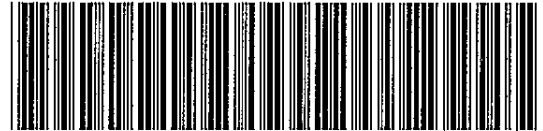

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).


1. Name. The name of this limited liability company is Romo Investment, LLC (“Company”).
2. Duration. The Company shall have perpetual existence.
3. Mailing Address and Street Address. The Company’s mailing address and street address is 1030 Arabian Drive, Loxahatchee, FL 33470.
4. Registered Agent and Office. The name of the initial registered agent of the company is Bruce W. Keihner. The street address of the initial registered agent of the Company is 125 Worth Avenue, Suite 330, Palm Beach, FL 33480.
5. Additional Members. Additional member(s) to the Company may be admitted, but only if a majority of the current member(s) agree(s) to the admission of the additional member(s) and to the terms of admissions.
6. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining member(s) may, by unanimous written agreement, continue the business of the Company.
7. Management of the Company. The Company shall be member managed by Edilmer Robledo.

8. Regulations. The member(s) shall have the power to adopt, alter, amend or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

9. Date of Existence of the Company. The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.


