ARTICLE III:

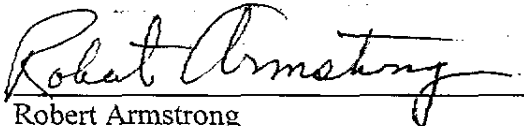

ARTICLE V:

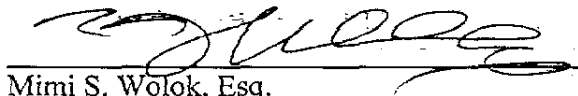
