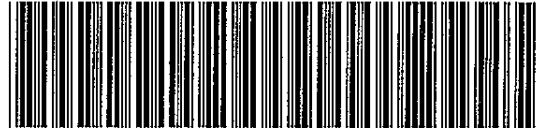



The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a member – managed company.




