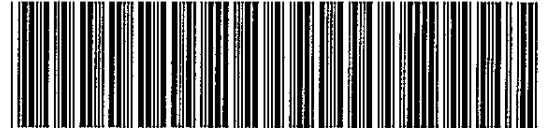

The name of the Limited Liability Company shall be AbCar MARKETING, LLC.


**ARTICLE II**


